1. HISTORY AND CULTURE OF SANGAM PERIOD

International School of Dravidian Linguistics is organizing two days' National Seminar on *History and Culture of Sangam Period* at V.I. Subramoniam Memorial ISDL Complex, St. Xavier's College P.O., Thiruvananthapuram – 695 586, Kerala on **25**th and **26**th **February 2021** to deliberate on the history and culture of Sangam period.

Subramoniam Memorial ISDL Complex, St. Xavier's College P.O., Thiruvananthapuram – 695 586, Kerala on **4**th and **5**th **March 2021** to discuss and evaluate the contributions made to Dravidian Linguistics after Dr. Robert Caldwell.

Review. TRIBAL DEVELOPMENT IN INDIA: FROM DESPAIR TO HOPE. T. Madhava Menon. 2020. Delhi: B.R. Publishing Corporation. Pp. 238.

The book Tribal Development in India: From Despair to Hope by T. Madhava Menon is a dedication to the late Shri. P.S. Krishnan (IAS Retd.). In this book, the author suggests the significance of implementing the Panchayati Raj system for steady development and the welfare of Scheduled Tribes (ST). He critically evaluates the mistakes of the governing bodies which have failed to restore and regenerate a total habitat development among the ST communities of Kerala. The policies to be implemented under the acts and laws are rarely fullfledged in practical context. The implementation failures of successive programs can be seen in this detailed study. The author directly and indirectly points out the key matters of demented development among ST-s.

The book begins with an introduction to the collected papers followed by five sections such as (a) Tribal development: Some Initial Observations, (b) People and Land Rights, (c) Development through

Education: Lessons and Prospects, (d) Case Studies, (e) Governance accompanied by the Conclusion, Bibliography, Index and certain selected photographs (from Attappady before and after the formation of Attappady Hills Area Development Society). These sections are further divided into 24 chapters.

The first section *Tribal Development: Some Initial Observations* consists of four chapters. In the Introduction, T. Madhava Menon pointed out that the penetration of Globalization and Liberalization causes a difference between the opulent minority and the common people. The worst forms of tyranny i.e., the laws which are not being enforced to protect those who are the intended beneficiaries, the poor facilities for instruction in their mother tongue at the primary stage etc., are focused here. He also states that, to a certain extent, the tribal communities are marginalized and are not able to obtain the eligible benefits of reservation in full.

In the second section, People and Land Rights', there are 8 chapters. Mostly the chapters deal with the wildlife of tribes in Kerala, the Forest Conservation Act 1980, recognition of rights (ST Act implementation), the effect of ST Recognition Act, difficult cases to deal with, eco-restoration and development of ST communities, the legislation and the property rights on the land. Though there are many acts existing in the state for Forest and Environmental conservation, the laws are unjustly twisted out of their declared objectives. After independence, the government tried to implement various schemes for the welfare of ST people but unfortunately most of them failed to achieve their objectives. The author covered the qualitative changes that had taken place with the implementation of the 'implication of inclusive growth' which gave priority to the increase of gross product. In fact, the Scheduled Tribes' main requisite is security. Even the Preamble of the Constitution of India defines the importance of the restoration concept (second paragraph of the Preamble).

"... and whereas the forests rights on ancestral lands and their habitat were not adequately recognized in the consolidation of State forests during the colonial period as well as in independent India resulting in historical injustice to the forest dwelling Scheduled Tribes and other traditional forest dwellers who are integral to the very survival and sustainability of the forest ecosystem; ..." (p. 65)

T. Madhava Menon opines that the safeguards assured in the constitution for ST/SC are in the nature of supplementary provisions to the basic structure and hence not implementable as rights. He suggests that the interpretation of this section should be based on the spirit of law. The author indicates that the technical compliance with a specific item of work, which is only a part of the larger work for which the lands are acquired, should not deprive the tribal people from obtaining the intended benefit (p. 85). The phase of achieving objectives for the rights of ST land is not so easy. It is stated that "about 90% of the tribal victims of land alienation in Kerala would be rendered ineligible for the benefit of restoration of the land they had lost' (p. 104). In the case of land alienation, greater injustice to the Scheduled Tribes can be found through the information the author has provided in this book.

The analysis of the experiences and existing reports shows that the performance level of the individuals comprising a community can be collectively improved by societal participation. If governance ensures equality of opportunity, then society will benefit. The project idea of a Central ST University for Peninsular (Andhra Pradesh, Telangana, Karnataka, Tamil Nadu and Kerala) is prepared for the intensive studies of microscopic communities to help to develop more beneficiaries among ST-s. Different programs like Linguistic and Cultural Studies (language treat), Distance education wing (access academic potential among ST students), Resident Program (award of degrees), Advisory Program (advisory notes to Government authorities for ST/SC affairs), Interactive Program etc., were

established (CIIL, ISDL) for the welfare of the tribes. There are ongoing programs that need further research. For ST-s, literacy is a non-traditional attainment.

The third section Development through Education: Lessons and Prospects includes 4 chapters which discuss (1) the genes and environment in Brain development, (2) the project idea of Central ST University, (3) Kerala Rules on Right to education - 2010 and (4) the models of past prospective on organizing tribal youth. The author draws attention to the Human Genome Project which mapped the genetic composition of human population worldwide (p. 109). This is mentioned here because he would like to point out that the universality probability of occurrence of excellency is not only connected to genetic mutations but also concurrently related to nature and nurture. It is said that, before the invasion of the British, the inhabitants of the forest were in harmony with nature without any exploitation and they had their own idealistic societal life. However, in the post-independence period, even after the establishment of the constitution, the ST-s were facing social and economic traps and barriers for their living a life of dignity. T. Madhava Menon argues for the protection of the ST rights in getting back their alienated lands for enjoying their lives in the forest to follow their traditional livelihood.
